Menus and price lists must be submitted for approval to the NIBROC Planning Committee.** If you do not submit a menu, your application will be put on hold until one is received. The committee reserves the right to delete items from a submitted menu in order to insure variety among the vendors. All menu decisions made by the committee are final; vendors who do not comply will be asked to leave the festival. No refunds will be given.

**NOTICE:** Space selection is by availability and at the discretion of the director. First come, first served. Your application will not be processed until all requirements are complete and payment in full is received. **Civic Group** vendors must submit documentation of tax-exempt determination.

**Food Vendors** - Pepsi Cola premix and products of the Pepsi Cola Bottling Company of Corbin, Kentucky are the exclusive drinks of NIBROC. No other soft drink products will be permitted. Call Pepsi Cola-Corbin at (606) 528-1635 to place your order for product or trailers directly. You must purchase your own supplies, including ice. Vendors are required by the City of Corbin to dispose of cooking oil or grease in containers provided by the Chamber (at locations noted on event Map) The City of Corbin will issue fines to any vendor or organization responsible for grease dumped into the city sewer drains. Violators will be removed from the festival and barred from participation in future Corbin events. No refunds of fees paid will be issued. **NO ROVING SALES, NO FREE ITEMS. OPERATION IS CONFINED TO YOUR RENTAL SPACE. NO SUB-LEASING OR SHARING OF BOOTH SPACE.**

**Church Groups** are required to have the Pastor of the Church sign the application. **Civic Groups** are required to have the President of the group sign the application. **School Groups** must have an advisor sign the application. Information provided will be verified.

**ALL APPLICANTS:** All fees must be paid by cash, money order, credit card (by phone), or certified check **NO PERSONAL CHECKS ACCEPTED.**
